No. 121957/1 dated 25.02.2022), the Shareholders' Assembly of the Company, at its annual meeting held on 31 May 2022, adopted the following

Proposed Resolution on the adoption of the Annual Report on Operations of the Company for the Year 2021

Article 1

The Shareholders' Assembly of the Company hereby adopts the Annual Report on Operations of the Company for the Year 2021, which is enclosed as integral part of the Resolution herein.

Article 2

The Controlling, Accounting and Tax Department shall organise the submission of the Annual Report on Operations of the Company for the Year 2021 to the competent state institutions in accordance with the legal regulations.

This Resolution shall enter into force on the day of its adoption.
